NOTIFICATION

(Regarding the Provisions of the Ordinance 124 of the University as Notified vide Notification No. F-13()/Res./MDSU/2014/78536 Dated 11.11.2014, w.e.f. 23.12.2014)

The Hon'ble Vice-Chancellor, in exercise of his powers vested under Section 19(4) of the University Act has approved the amendments w.e.f. from the session 2014-15 in the provisions of Ordinance 124.7.A, 7.E as under:

A. The existing provisions as notified vide Notification No. F-13()/Res./MDSU/2014/78536 Dated 11.11.2014, w.e.f. 23.12.2014 is substituted by the following:

O.124.7 Research Eligibility Test (RET)

A. There shall be an Entrance Test namely **Research Eligibility Test (RET)** comprising of two papers of 100 marks each. The duration of each paper shall be one hour. Paper I shall be of General Paper on Teaching and Research Aptitude and the Paper II shall be from the subject selected by the applicant. An applicant who does not appear in Paper I shall not be allowed to appear in Paper II. Paper I and Paper II shall consist of 50 Multiple Choice Questions. Each question shall carry 2 marks. There will be no negative marking.

The questions for paper I & II shall be based on the syllabus of National Eligibilty Test (NET) of UGC/CSIR in a particular subject selected by the applicant.

E. Weightage of percentage of the academic record such as Sr. Secondary, Graduation, Post Graduation, Permanent Faculty (Higher.Education) & Fellowships (UGC/CSIR) shall be as follows:

Qualification	Weightage
(i) Sr. Secondary	10%
(ii) Graduation	20%
(iii) Post Graduation	40%
(iv) NET/SLET	10%
(v) Permanent Faculty (Hr.Edu.)	10%
(vi) Fellowships (UGC/CSIR)	10%
