Special Ed. (HI) (with 30 Seats) for the session 2021-22 subject to fulfillment of the conditions as mentioned below:-

- "To follow and observe the University Act, Statutes, Ordinances, Regulations, Rules and Instructions framed, amended, adopted and issued from time to time in General and specifically relating to:
  - Admissions of students in the above course. (a)
  - To follow curricula/Courses of study as prescribed by the University from time to time including scheme of examinations and conduct of examinations.
  - Appointment of Teaching / Sports / PTI / Library Staff." (c)
- All the conditions as prescribed by the State Govt. in the N.O.C. No. 2. (i) F.1 (13)26/22/नि.वि.यो./पंजी/ 2020/9833 Dated 13-10-2020 and RCI letter No. 17-1152/B.Ed. Spl. Ed. (HI)/21/RCI/ dated 18-01-2022 will have to be followed and compliance report of fulfillment of all conditions will be submitted within three months.
  - Staff: Appointment of permanent and qualified Principal and (ii) teaching staff on the fulltime basis selected by a duly constituted Committee as per the norms of RCI/State Govt./UGC before the commencement of the session.
  - That the reserve fund for an amount equal to three months salary (iii) of the Teachers and Staff be created within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of not less than sixty months (Five Years) in a Nationalized Bank.
  - (iv) Building: Construction of sufficient building as per guidelines of the RCI/University provisions, play grounds and hostel building.
  - (v) Library: Year wise development of college Library and provision of funds for journals and magazines be made.
  - (vi) Faculty Members: At least two faculty members in each faculty be appointed as per the decision of the Academic Council and Board of Management already circulated to the Principals of all the affiliated Colleges of the University.
    - To make compliance and fulfillment of the conditions lay down in your affiliation letter and submit it within two months from the date of issue of this letter.
- To provide the information as asked for by the University from time to time including Statistics etc. (17
