

Minutes of Meeting dated 07.06.2024

A meeting regarding implementation of Skill Courses in the selected government colleges as per the memorandum of Understanding (MOU) signed between the Higher Education department, Govt. of Rajasthan and Centre for Research in Schemes and policies (CRISP) was held on 07.06.2024 in the Conference Hall, Secretariate.

Meeting was presided over by The Principal Secretary Higher Education. Commissioner College Education along with Additional Commissioner and other Joint directors, officers from the college education department and higher education department also attended the meeting.

Meeting began with a brief introduction of skill courses which have been selected to be introduced in the current academic session. Such courses are being implemented in other states also such as Telangana, Uttar Pradesh, Madhya Pradesh etc. These are apprenticeship embedded programmes and shall ensure employability for students. Courses shall have 50% general component and 50 % skill component. Mr. Radhey Shyam Julhaniya from CRISP exhorted all the participants to support the programme whole heartedly as this was a way of giving back to the society and ensuring employability for the students. He stressed upon the fact that to ensure employability there was need to bridge the gap between the industry and the Academia and the proposed courses have been designed to do so. These courses have been developed by the Sector Skill Councils in line of National Education Policy (NEP-2020) in consultation with CRISP. Sector Skill Councils will provide all the necessary support in running these courses such as Teacher Training and Faculty support.

Courses which are being introduced are as follows:

1. Retail management
2. BFSI
3. Life Sciences
4. Logistics
5. Health Care

These proposed courses do not require any initial capital investment or infrastructure. Courses requiring laboratories or capital investment such as Media and Entertainment shall be taken up from next year.

Steps to be followed for implementation of these courses were enumerated as follows:

1. Approval of courses by the BOS of the university
2. Application for affiliation of the courses by the colleges
3. Courses to be integrated in the Admission portal
4. Identification of Champion Professors in the colleges
5. MOUs to be signed between Sector Skill Councils and individual Colleges

Vice Chancellors of the State Funded Universities joined the meeting and expressed their apprehensions regarding Board of study approval and related issues. Pr. Secretary Digitally signed by Anuj Saxena Designation : Joint Secretary Date: 2024.06.12 19:49:59 IST Reason: Approved



directed that the courses were to be implemented from this year only and top students are to be admitted in these courses. Universities asked for a draft regarding affiliation to be prepared and shared by the department along with directions that no affiliation fee would be charged. Universities were directed to approve the courses by 15 June 2024.

As per the CRISP officers a minimal fee (approximately Rs 5000 per student per year) has been finalised in consultation with the Sector Skill Councils that would be charged from the students for these courses. Proposal for payment to be made to the CRISP/Sector skill councils was proposed to be sent to the Finance Department.

Officers of CRISP urged departmental officers to make efforts to publicize the courses. These will include creation of awareness among students for the programmes, display on website, exhibiting on notice boards and use of social media for this purpose. Organisation shall prepare Frequently Asked Questions (FAQs) to address doubts if any.

Meeting ended with Vote of thanks.
