Dear Sir,

.This is to inform you that on the basis of the Inspection Report and recommendations of the Affiliation Committee, the Hon'ble Vice-Chancellor has been pleased to grant fresh affiliation to your College for starting **B.Ed. course (with 100 Seats) (Two unit-50 students per unit)** dully allotted through the P.T.E.T. as per N.C.T.E. norms for the Session **2019-20.**, subject to fulfillment of the conditions as mentioned below:-

1. "To follow and observe the University Act, Statutes, Ordinances, Regulations, Rules and Instructions framed, amended, adopted and issued from time to time in General and specifically relating to :
 - (a) Admissions of students in the B.A. B.Ed. Course and B.Sc. B.Ed. Course will have to be made up to the allotted seats.
 - (b) To follow curricula/Courses of study as prescribed by the University from time to time including scheme of examinations and conduct of examinations.
 - (c) Appointment of Teaching/Sports/PTI/Library Staff."

 - (i) All the conditions as prescribed by the State Govt. in the N.O.C. No. F.24(NOC 19-20) / B.Ed./Akashi/19/326 dated 08-07-2019 and NCTE recognition letter No. NRC/ NCTE/Application No. -2016-16470(ID No. 11163)287/ Meeting 2018/195910 dated 2-August-2018 will have to be followed and compliance report of fulfillment of all conditions will be submitted within three months.
 - (ii) Staff: Appointment of permanent and qualified Principal and teaching staff on the fulltime basis selected by a duly constituted Committee as per the norms of NCTE/State Govt./UGC before the commencement of the session.
 - (iii) That the reserve fund for an amount equal to three months salary of the Teachers and Staff be created within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of not less than sixty months (Five Years) in a Nationalized Bank.
 - (iv) Building: Construction of sufficient building as per guidelines of the NCTE/University provisions, play grounds and hostel building.
 - (v) Library: Year wise development of college Library and provision of funds for journals and magazines be made.
 - (vi) Endowment Fund: Submit an attested copy of the FDR amounting to Rs. 5.00 Lacs created with the joint signature of the Registrar, MDS University, Ajmer and College towards Endowment Fund within one year from the issue of this affiliation letter.
 - (vii) Faculty Members: at least two faculty members in each faculty be appointed as per the Principals of the affiliated Colleges of the University.
 - (vii) To make compliance and fulfillment of the conditions laid down in your affiliation letter and submit it **within two months** from the date of issue of this letter.
3. To provide the information as asked for by the University from time to time including Statistics etc.

4. To follow strictly rules and regulations and amendments governed by the University & NCTE from time to time.
